California Transparency in Supply Chains Act (SB 657)

Effective January 1, 2012, the California Transparency in Supply Chains Act requires retail sellers and manufacturers doing business in the State of California with more than \$100,000,000 in annual worldwide gross receipts to disclose their efforts to eradicate slavery and human trafficking from their direct supply chain for tangible goods offered for sale.

At ASC Profiles we recognize our social responsibility as part of the community in all regions in which we operate and within our supply chains We support the elimination of all forms of forced or compulsory labor, the abolition of child labor and require our suppliers to do the same.

Consultants, contractors and business partners working with or for us are to be informed of our relevant policies and guidelines and of the requirement that they act in accordance with them.

Our contracts and our standard terms require that our vendors act in accordance with all laws applicable to them, which include laws dealing with human trafficking and slavery.

We use a process that assesses the sustainability risks, including the risk of modern slavery, and business leverage that exists with our suppliers in order to prioritise our due diligence efforts. For high priority suppliers we conduct due diligence with the supplier to understand their approach to managing the risk of modern slavery in their operations and supply chains, and we also review the supplier's performance in this regard. Our assessment processes can include: due diligence database searches, desktop research, self-assessment questionnaires and on-site assessments by 3rd party auditors.

We have trained our business leaders and procurement teams on our Supplier Code of Conduct and supply chain sustainability processes, which includes awareness of modern slavery risks.
